Air Emission Results for A1 & A2 2025

Emissions to air at the Felindre site are calculated using a predictive emission monitoring system software.

Q1: January to March, Operator has submitted the relevant results for all quarterly parameters required over this period. Results have been assessed and are compliant with that stated in Table S4.1 with no breaches of ELV. Monitoring returns received within the 28 days as stated in condition 4.2.2 in permit.

Q2: April to June, Operator has submitted the relevant results for all quarterly parameters required over this period. Results have been assessed and are compliant with that stated in Table S4.1 with no breaches of ELV. Monitoring returns received within the 28 days as stated in condition 4.2.2 in permit.

Q3: July to September, Operator has submitted the relevant results for all quarterly parameters required over this period. Results have been assessed and are compliant with that stated in Table S4.1 with no breaches of ELV. Monitoring returns received within the 28 days as stated in condition 4.2.2 in permit.

Q4: October to December, Operator has submitted the relevant results for all quarterly

parameters required over this period. Results have been assessed and are compliant with that stated in Table S4.1 with no breaches of ELV. Monitoring returns received within the 28 days as stated in condition 4.2.2 in permit.

Emissions to Water

Biannual 1 January to June 2025: Analysis of emission to water revealed no visible oil or grease contamination of the site discharge point. Compliant with Table S4.2 of the environmental permit.

Biannual 2 July to December 2025: Analysis of emission to water revealed no visible oil or grease contamination of the site discharge point. Compliant with Table S4.2 of the environmental permit.

Annual Performance Parameters

The annual performance parameter report was returned alongside the 2025 Q4 monitoring submission.

All required performance parameters have been recorded, and the reported values are considered satisfactory.

This CAR report and assessment was undertaken on 04th February 2026. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS system has been altered to 31st Dec 2025.
