Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

## 4. Details of our assessment

A routine monitoring sample was taken by NRW on the 7th January 2026.

The ammonia result was 50.2 mg/l whereas the permit limit is 2 – this result is **25x the limit** and our scoring guidance categorises anything as >3x the limit as a category 1 failure. This means it has the potential to have a **MAJOR environmental impact**.

The biological oxygen demand (BOD) result was 35mg/l compared to the permit limit of 20mg/l. This is classed as a category 3 failure - it has the potential to have a minor environmental impact.

Following the sample failure in November, the site was investigating ways to balance flows during a period of low flow and load.
