4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the 2025 annual monitoring returns (1 January - 31 December) by Dunbia (UK) (the operator) for activities at Cross Hands Business Park West, Cross Hands, Carmarthenshire SA14 6RF under environmental permit EPR-BU8002IT.

This compliance assessment was undertaken on 6 February 2026. However, to ensure that the CCS score is attributed to the correct financial year for billing purposes, the date on CAR has been adjusted to 31 December 2025.

Annual Monitoring Returns 2025

Permit condition 4.2.2 requires the operator to:

“A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year. The report(s) shall include as a minimum:

- a. a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data;*
- b. the annual production / treatment data set out in schedule 4 table S4.2; and*
- c. the performance parameters set out in schedule 4 table S4.3 using the forms specified in table S4.4 of that schedule.”*

2025 Annual Performance Summary

The 2025 monitoring data submission provides information on the operator's emissions to air at monitoring point **A7**, energy consumption (electricity and natural gas), water usage, and waste regimes.

Commentary is included comparing the results with previous years and identifying changes linked to operational activity. There were no notable concerns identified in relation to the information submitted.

Compliance Summary

- The monitoring return submissions were sent within the reporting period, which is compliant with **permit condition 4.2.2**.
- The monitoring return submissions for **Q1, Q2, Q3, and Q4 (2025)** were all made within the respective reporting windows, in compliance with **permit condition 4.2.3**.
- The monitoring returns submitted include monitoring carried out in respect of the parameters and emission points specified in **Tables S4.1, S4.2, S4.3, and S4.4** of Schedule 4, which is compliant with the environmental permit.
- The monitoring returns submitted relate to the reporting periods specified in **Table S4.2** of Schedule 4, which is compliant with the environmental permit.
- The monitoring returns include the results, assessments, and information required by **Table S4.4** of Schedule 4, in compliance with the environmental permit.

Overall conclusion

Based on the reports submitted by the operator, all emissions at the monitoring points and all permitted parameters appear to be compliant with the specified emission limits.
