This compliance assessment report (CAR) details the following:

- Quarter two (April - June) 2025 waste returns
- Quarter four (July - September) 2025 waste returns
- Quarter four (October – December) 2025 waste returns
- Review of the annual performance parameters for 2024 as required by permit condition 4.2.2

Quarter two (April - June) 2025 waste returns

The waste returns for quarter four were received within the reporting window. A total of 486.74 tonnes of waste was received and a total of 490.78 tonnes removed during this period. All received EWC codes were compliant with the permit.

Quarter three (July – September) 2025 waste returns

The waste returns for quarter four were received within the reporting window. A total of 475 tonnes of waste was received and a total of 485.54 tonnes removed during this period. All received EWC codes were compliant with the permit.

Quarter four (October – December) 2025 waste returns

The waste returns for quarter four were received within the reporting window. A total of 572.34 tonnes of waste was received and a total of 587.92 tonnes removed during this period. All received EWC codes were compliant with the permit.

Annual Returns

A total of 823 tonnes of waste was processed through the installation during 2024, well within permitted limits.

Water usage – A total of 125m³ of water was used by the installation, this equated to a specific usage of 0.067m³ per tonne of waste processed through site, a reduction on the previous year.

Energy use - A total of 76.44 MWh of primary energy was used by the installation (31.853 MWh delivered electricity with conversion factor of 2.4). This equated to a specific usage of 0.041 MWh per tonne of waste processed, a reduction on the previous year

No raw materials reported to be used at the installation.

As the installation is primarily a transfer station with no treatment operations being conducted, the use of electricity and water is primarily for ‘domestic’ purposes, however, it is positive to see apparent increases in efficiency.

Total waste received on to site has been reported as 1869 tonnes.
