4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the **Q3** (July - September) and **Q4** (October - December) 2025 monitoring returns by Dunbia (UK) (the operator) for activities at Teify Park Abattoir and Meat Processing Plant, Lampeter Road, Llanybydder SA40 9QE under Environmental Permit EPR-BV9683IH.

Q3 and Q4 2025 Monitoring ReturnsEmissions to water – Q3 and Q4 Water

The returns for reporting of sampling and analysis of emissions to water (other than sewer) to emission point W2 for Q3 (1 July - 30 September) and Q4 (1 October - 31 December) 2025 were submitted to NRW on 16 October 2025 and 7 January 2026.

The parameter listed for emissions to W2 were:

(i) Total suspended solids, (ii) pH, (iii) BOD, (iv) Ammonia, and (v) Volume/Flow rate.

- The monitoring data was sent within the Q3 and Q4 reporting periods, which is compliant with permit condition 4.2.3.
- The monitoring was conducted inside the Q3 and Q4 monitoring periods, which is compliant with permit condition 3.6.1.
- The monitoring returns submitted includes reporting of monitoring carried out in respect of the parameters and emission points specified in table S4.1 of schedule 4, which is compliant with the environmental permit.
- Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified limits over the Q3 and Q4 2025 reporting periods.

Quarterly Waste Effluent Inputs to ETP - Form 4.2.5

These documents were submitted to NRW on 16 October 2025 and 7 January 2026.

- This data was sent within the reporting periods, which is compliant with permit condition 4.2.5.
- The reports details a NIL return.
- Based on the report submitted by the operator, the waste data appears **compliant** with the specified permit requirements over the **Q3** and **Q4** 2025 reporting periods.
