4. Details of our assessment

Perimeter Odour Inspection - Llanddulas Compost Site

Following an odour incident/complaint from a local resident, a compost site perimeter odour inspection was conducted at 13:30 hrs on the 30th of December 2025 for evidence of off-site odour from the FCC Llanddulas compost facility.

The atmospheric conditions were calm and cool, which are the conditions in which odour issues would be most prevalent and detectable in these areas. There was a faint smell of compost odour in the air but at the time of inspection it was barely detectable. The permit condition relating to odour states the following:

3.2 Odour

3.2.1 Emissions from the activities shall be free from odour at levels likely to cause pollution outside the site, as perceived by an authorised officer of the Environment Agency, (for Environment Agency read NRW) unless the operator has used appropriate measures, including, but not limited to, those specified in any approved odour management plan, to prevent or where that is not practicable to minimise the odour.

The trace of odour was very low level and upon investigation the site was adhering in full to the previously agreed Compost and odour Management Plan so no score has been attributed on this occasion on interpretation of the part of the permit condition highlighted in bold above.

Further unannounced perimeter odour inspections may be undertaken by NRW over the coming months to ensure continuing compliance.
