4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised following a review of the annual reporting requirements and 6 monthly monitoring of air emissions.

The annual and 6 monthly reports were submitted on 28th January 2026 in compliance with permit condition 4.2.2 and 4.2.3.

Air emissions monitoring was undertaken on A1 emission point on 30th October 2025 and the results were all in compliance with the emission limit values (ELV's) applied by permit condition 3.5.1 Schedule 3 Table S3.1.

No leachate was discharged from emission point S1 as all the waste water is removed by tanker for off-site disposal.

The bio-aerosol monitoring was undertaken on 29th November 2025 and all the results were in compliance with the ELV's applied by permit condition 3.5.1 Schedule 3 Table S3.4.

As per permit condition 3.5.1 Schedule 3, Table S3.3 a report must be submitted annually detailing the efficiency and effectiveness of the bio filter. This was completed on 30th October 2025 and the reported efficiency was 95%.

Waste Returns Q3 & Q4 2025

Condition 4.2.5 requires that quarterly waste returns for the previous quarter shall be submitted within one month of the end of the reporting period. Waste returns were submitted for quarter 3 and 4 in 2025 in compliance with permit condition 2.3.2 (a), Schedule 2, Tables S2.1 and S2.2. Waste returns have been reviewed and no issues found.
