4. Details of our assessment**Bio-aerosol monitoring**

Bio-aerosol monitoring was undertaken in accordance with Condition 3.7.1 (a). The permit requires bioaerosol monitoring to be undertaken twice a year.

Table S3.1 specifies limits for bio-aerosol concentrations as:

- Total bacteria - 1000 cfu/m³
- Aspergillus fumigatus - 500 cfu/m³
- Gram negative - 300 cfu/m³

The bio-aerosol monitoring was undertaken on 29th October 2025 and the concentrations were compliant at all sampling locations during this monitoring exercise.

Process monitoring was undertaken in accordance with Condition 3.7.1 (b).

Table S3.2 specifies a report must be submitted to NRW detailing the efficiency and effectiveness of the biofilter. This report was conducted on 30th November 2025 and efficiency was measured at 93.2%.

Waste Returns Q1-Q4 2025

Condition 4.2.2 requires that waste returns for the previous quarter shall be submitted within one month of the end of the quarter. Waste returns were submitted for all quarters in 2025. Waste returns have been reviewed and no issues found. The quantity of waste accepted for 2025 was well below the permitted limit.
