4. Details of our assessment

On 14 January I attended site on a pre-arranged inspection with colleagues Kirsty Allwood, Jannette Price and Kate Gwynn. The weather was cold but dry and bright.

On arrival we signed in and spoke with the Ops Manager and discussed some of the previous arrangements for sampling. We also confirmed the layout of the site and operation of pumps and discharges – this hadn't changed since my previous inspection in 2024.

We then left to inspect the sample point and confirm sampling procedure for NRW staff. At the sample point, there was evidence of contamination – most likely from heavy rainfall in the preceding days – and the settlement lagoons were full. On returning to the office we discussed with the Ops Manager that the contamination from the surface water run-off could be contaminating the final effluent by bypassing the lagoon systems, and that options should be considered to retain/control the surface water flows and prevent them entering the system in this manner. The Ops Manager was very amenable and verbally agreed this would be investigated further. I have included this as Action Only given there was no breach of conditions.
