## 4. Details of our assessment

A Routine site inspection of Grosmont WWTW Wastewater Treatment Works carried out by Environment Officer Peter Jones. The permit was last varied on the 25 July 2024, the varied conditions come into effect from the 28 January 2028.

Effluent enters the works by gravity flow. The intake chamber is relatively small, to prevent the screen from blinding, which causes the effluent to surcharge from the chamber. 30 and 20 mm screens are utilised to catch solids entering the works. There is currently no requirement in the permit for 6 mm screens. From the intake effluent flows into the Primary Settlement Tank.

Sludge from the PST is removed by manually opening a valve, the sludge then flows down to the sludge tank.

Following settlement in the PST, the effluent flows into, two filter beds. The filter bed medium looks to be well maintained and the rotating arms are operating effectively. There's no moss growth or pooling on top of the beds. The effluent then passes to the humus tank. On entering the humus tank, the effluent passes under a baffle and the flow splits into two tanks.

The sludge tank, utilises a weeping wall, constructed from railway sleepers, to separate the liquid fraction. The liquid fraction of the sludge passes through the weeping wall into a channel from where the effluent is pumped back to the head of the works. The residual sludge in the tank is removed and taken from site by tanker.

The final effluent looked clear and of good quality, samples were not collected. The site diary was up to date.
