4. Details of our assessment

Purpose of Visit

The purpose of the visit was to confirm the location of the registered Environmental Permitting Regulations (EPR) water discharge activity associated with Permit CG0098501.

Summary of Site Meeting

Upon arrival, Natural Resources Wales (NRW) Officers were greeted by the General Manager, who provided access to the relevant areas of the site. Officers carried out a inspection of the premises but were unable to locate either a discharge point or the associated treatment plant.

During discussions, the General Manager confirmed that they were unable to provide any information regarding the location of the treatment plant or the discharge point connected to the permitted activity.

It was also noted that the permit is not currently registered under the correct operator name.

Actions Required

1. Identify and confirm asset locations

The operator is required to locate both the treatment plant and the associated discharge point and provide full details to Natural Resources Wales.

2. Correct the operator details on the permit

The operator of the treatment plant must be correctly named on the permit. The operator is therefore required to apply for a permit variation to update the operator details in accordance with regulatory requirements.

Due Date

The deadline for completing and submitting evidence of both of the above actions is:

30 April 2026
