4. Details of our assessment

CARS form generated following inspections of sewage treatment plant on the 09/02/2026 at Shell Island that serves a toilet and a shower block. Permit number WQD005745.

The local Environmental officer met on site with Shell Islands director at 10am. The director explained how the package treatment plant worked and explained where the treated effluent discharges too.

Prior to the visit it had come to our attention that Natural Resources Wales samplers could not access the permitted discharge location which is the outfall as its under water.

The site director proposed that samples could be taken from a final chamber within the package treatment plant. Following assessment, NRW determined that this chamber is not appropriate for sampling because the water within it is stagnant and may contain algae, and bits of foul waste, which could compromise the integrity and representativeness of sample results.

For Action

Please add a final effluent sample chamber where ideally there is a drop from the in flowing treated effluent where the samplers can collect a sample of flowing water.

Natural Resources Wales would then accept that the sample point is not at the permitted location but at a location that is accessible for samples to be taken.

Deadline

Natural resources Wales would like to give you until the 30/06/2026 to construct a final effluent sample chamber.
