4. Details of our assessment

PERMIT INSPECTION

On Tuesday 20th January 2026 NRW Officers Cerys PHILLIPS, Nicola ROSSITER and Leah GOLDING attended the facility at 12:05 pm for an unannounced routine inspection of permit number EPR-HB3597TC. The weather was raining at the time of inspection.

Upon arrival at the site, NRW officers met with Andrew LEWIS who gave a brief introduction regarding the site processes.

The site was operational at the time of the inspection. It was organised and appeared well managed. General housekeeping on site was of a good standard.

Officers were escorted to the upper area to the composting windrows and drainage lagoons. The windrows were no taller than 4m in height with sufficient space between for fire safety.

The sealed drainage system appeared to be in good condition at the time of inspection. Drainage lagoons are collected/emptied on an ad-hoc basis.

Officers were then escorted to the initial sorting area where waste is offloaded and processed/shredded prior to composting.

Here, contaminants are picked out and separated, this contamination is returned to the customer for them to dispose of correctly.

There was no excessive noise and no airborne dust present during the site inspection. There were also no offensive odours witnessed by NRW Officers on site.
