Intended Use

Summary of Water Demand and Justification for Abstraction from Spring

The hospital provides 24-hour residential care for up to 74 patients, all of whom require a constant and reliable water supply to support daily living, personal hygiene, and clinical care. In addition, we have an office block that provides facilities for 60 staff. 20 of the bedrooms are a self-contained en-suite bathroom, creating a continuous baseline demand for water associated with showering, handwashing, toilet use, and general sanitation. This layout, while essential for patient dignity and infection-control compliance, results in higher per-patient water usage compared with facilities with shared amenities. The remaining 54 bedrooms have sink facilities whilst each ward has a communal shower and bathroom block.

Daily operations also rely on the support of an average of 123 staff members, whose clinical, support, and administrative duties necessitate regular access to water, particularly for hand hygiene, cleaning, and use of ancillary facilities. As a healthcare environment, water demand is inherently higher due to stringent infection-prevention requirements.

The site further includes a main kitchen, four satellite kitchens and three practice kitchens, each in daily use for meal production, food service, equipment washing, and general catering operations for both patients and staff. These areas require a dependable water supply to meet food-safety regulations and maintain service continuity.

Collectively, these factors create a substantial and consistent demand for water across the hospital. Abstraction from the spring at the current abstraction rate of 7500 cubic metres per year is therefore essential to meet current usage levels and ensure the resilience of the supply. Operating at the reduced rate currently would pose an unacceptable risk of service disruption; maintaining spring supports continuity of patient care, adherence to regulatory standards, and operational resilience.
