4. Details of our assessment

CARS form generated following inspections of the package treatment plant serving Plas Waenydd on 12/02/2026. Permit number: AB3890CM.

The local Environmental Officers met on site with the Plas Waenydd General Manager at 10:30am. During the visit, the Director described how the package treatment plant operates and showed the team where the treated effluent is discharged.

Prior to the visit, it had come to our attention that Natural Resources Wales (NRW) samplers were unable to access the permitted discharge location due to health and safety concerns.

NRW determined that the outfall pipe is situated in a location that presents a fall risk for samplers attempting to collect compliance samples.

3.3.2 Permanent means of access shall be provided to enable sampling/monitoring to be carried out in relation to the emission points specified in schedule 3 tables S3.1, S3.2 and S3.3 unless otherwise agreed in writing by Natural Resources Wales.

For Action

Please install a final effluent sampling chamber. Ideally, this should include a drop in the incoming treated effluent, allowing samplers to collect a representative sample of flowing water. The chamber must be positioned in a location that is safe and easily accessible for samplers.

Deadline

Natural Resources Wales requests that the final effluent sampling chamber be constructed by **30/06/2026**.
