4. Details of our assessment

This CAR form is being issued as a result of a pollution incident that was self-reported by Dwr Cymru on the 22nd of January and recorded on WIRS as incident number 2600765.

The incident arose as a consequence of a gearbox failure on the half bridge on the final settlement tank.

Although action was taken to mitigate the issue, the turbidity of the final effluent increased to the point where it had to be self-reported by Dwr Cymru to Natural Resources Wales in accordance with GN018.

The elevated turbidity would be indicative of elevated solids levels if samples had been taken and analysed, and therefore a likely permit breach under the emissions limits.
