4. Details of our assessment

The purpose of this Compliance Assessment Report is to:

- Record our findings following a site inspection

On the 29th January 2026 we carried out an inspection of Devmt Off Donvant Road/ Byron Way Hendrefoilan Sewage Pumping Station (SPS) in conjunction with DCWW. There was light rainfall during our visit, it had been raining overnight and on the days preceding the inspection.

The descriptive permit for this SPS allows for a discharge in an Emergency only as defined in the permit conditions. There is no permit in place to discharge storm sewage.

We understand that Devmt Off Donvant Road/ Byron Way Hendrefoilan SPS is included in the AMP8 MCERTS EDM installation programme which is due to be completed by March 2030.

The SPS has a large wet well with an Emergency Overflow (EO). We observed a 10mm bar screen as specified in the permit. The screen was free of any debris.

You told us that the wet well had a high level alarm and we observed a sensor within the chamber.

The wet well appeared clear of excess sewage debris during the inspection. The flows are foul only and were low during the inspection. You informed us that there was a small amount of infiltration into the network

You informed us that the pumps would be on a 2 yearly maintenance programme and the wet well would be on a 12 month wet well clean unless requested sooner.

We observed two pumps at the SPS, you told us that they were duty and standby. You confirmed that they were alarmed and the pumping station would automatically restart following an external power failure. There was a record on site that one of the pumps had been replaced in March 2025.

The permitted storage is equivalent to a total of at least 6 hours DWF. We discussed this during the inspection and you thought the storage within the wet well could offer the storage as permitted. In addition to the wet well there was additional storage capacity provided within the interceptor chamber. We did not measure the storage during the inspection.

The permitted discharge point for the Emergency Overflow is to the Nant yr Olchfa SS 60900 93613. We carried out a visual inspection of the outfall and flap valve which appeared clear of any sewage debris or signs of a recent discharge. The flap valve was slightly buried under deposited silt and gravel which was easily cleared during the inspection.

We could see that there are facilities for a mobile generator connection and tanker access

if required.

During this inspection, we did not identify any non-compliances.
