#### 4. Details of our assessment

On 7 January 2026, a routine compliance sample was taken which exceeded the allowable limits for Biochemical Oxygen Demand (BOD) as described within the emissions and monitoring schedule of Permit AN0359601 (Schedule 3- Table S3.1). The sample contained >79mg/l BOD, with an allowable limit of 40mg/l.

**This noncompliance has been assessed as a Category 3 breach of the permitted condition.** A noncompliance which could have a minor environmental effect .
