**4. Details of our assessment**

This CAR form has been prepared to cover the annual and quarterly reporting for 2025 which Sherwin-Williams UK Ltd is required to submit to Natural Resources Wales to comply with the permit requirements.

**Annual Submissions**

The annual submissions which were due to be reported to NRW by 31st January 2026 were received within the required time period. Reports have been received for total water usage; raw materials; annual energy usage; and solvent usage, in accordance with permit condition 4.2.2 .

**Annual Emissions for Quarters 2, 3, and 4**

Annual emissions for quarters 2 - 4 have been reported in accordance with permit condition 3.3.1(a) Schedule 3; table S3.1.

Quarter 2 emissions were submitted to NRW on 2nd May 2025.

Quarter 3 emissions were submitted to NRW on 1st September 2025.

Quarter 4 emissions were submitted to NRW on 30th January 2026.

All of emissions reported are within the required limits set out in table 3.4. You have confirmed that there are currently no emissions from points A4 & A6, as the new plant is not yet operational.

**Solvent Management Plan**

The annual solvent management plan which covers the Reporting of emissions to air was reported in accordance with permit condition 4.2.5, and within the required time period. The report contained the required information including calculations for emission points A5 and A37.

A review of the solvent management plan was undertaken on 5th February 2026, and shows that solvent emissions are compliant with the 3% emission limits . Solvent emissions were reported in accordance with permit condition 3.3.1, schedule 3, Tables S3.1 and S3.4.
