4. Details of our assessment

Annual Monitoring Returns 2025

This Compliance Assessment Report (CAR) has been issued in response to the submission of the 2025 Annual Monitoring Returns by **Sensient Flavours Limited** and **Volac International Limited*** for activities at **Felinfach Effluent Treatment Plant, Felinfach Industrial Estate, Lampeter, Ceredigion, SA48 8AG** under permit **EPR/BP3135EB**.

**Note: Volac International Limited was acquired by Arla Foods Ingredients in April 2024. Sensient Flavours Limited is no longer operational at the Felinfach site. A permit variation is pending to reflect these operational and ownership changes.*

The following monitoring returns and reports have been assessed as part of this CAR:

- *Reporting of emissions to water for the period: 01/01/2025 to 31/12/2025*
- *Reporting of Water Usage for the period: 01/01/2025 to 31/01/2025*
- *Reporting of Energy Usage for the period: 01/01/2025 to 31/01/2025*
- *Reporting of other performance indicators for the period: 01/01/2025 to 31/12/2025*

This CAR was completed on **12 February 2026**. However, the date on the CAR form has been amended to **31 December 2025** to ensure the Compliance Classification Scheme (CCS) score is attributed to the correct financial year for billing purposes.

Compliance Assessment

Table S4.1 (Schedule 4(b)) of the permit specifies that the annual reporting period for emissions to water commences on the **1 January**. Condition 4.2.3 requires the operator to submit all annual reports within 28 days of the end of the reporting period. A short extension was granted by the site's regulating officer on **28 January 2026**.

The operator submitted the required annual reports on **30 January 2026**, in compliance with permit requirements.

Emissions to Water

The operator submitted the *Reporting of Emissions to Water for the period 01/01/2025 to 31/12/2025* using the agreed reporting format (**Form Water1 / 17/08/2022**).

- All parameters required under the permit's Emission Limit Values (ELVs) were reported.
- **No exceedances** of ELVs were identified.

Performance Reports

Condition 4.2.2 of the permit requires the operator to submit annual performance reports by **31 January** each year. The operator submitted the 2025 Annual Performance Reports on **30 January 2026**, using the agreed reporting forms, in accordance with Condition 4.2.2(c).

Water Usage

The operator submitted the 2025 annual Water Usage data for both mains supply and the site boreholes in accordance with Table S4.3, using the approved reporting format (**Form WaterUsage1 / 17/08/2022**).

- **No issues were identified** with the submitted information.

Energy Usage

The operator submitted the 2025 annual Energy Usage data in accordance with Table S4.3, using the approved reporting format (**Form Energy1 / 17/08/2022**).

- **No issues were identified** with the submitted information.

The operator has also indicated that an internal review of energy consumption is planned for 2026.

Performance Indicators

Annual reporting for 2025 Performance Indicators was submitted using the approved form (**Form Performance1 / 17/08/2022**), in compliance with Table S4.3.

The report included data relating to: Treated liquid effluent discharged at monitoring point W1, Sludge removed for off-site recovery, consumption of sodium hydroxide.
