Natural Resources Wales officers Shaun Rees and Kirsty Allwood met with Mr Gary Mountford to carry out a routine audit of the site on the 9 February 2026 at 10:30.

Mr Mountford explained that the site manager had phoned in sick that day and that he would be assisting us with the inspection, Mr Mountford also stated that the site manager had handed in his notice and had been messing him around.

A walk around the site was not permitted, as Mr Mountford, was concerned with Avian Influenza, so not all part of the permit were inspected.

You will be happy to hear that no non compliances were identified with the parts of the permit inspected on our visit.

A historic non compliance is currently in progress between NRW permitting and site's consultant.
