Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

Environment Officer Peter Jones attended on 23 February 2026 to carry out a routine site inspection.

The site Manager provided assistance during the site visit. The inspection took the form of a visual check on the site drainage and exterior infrastructure and a review of the sites management documents and supporting records. The site details and relevant contact numbers are clearly displayed at the site entrance.

The overall condition of the four sheds is good and the concrete hard standing is in good condition. There was no evidence of the dirty water tanks overflowing or a dust build up around the poultry sheds. There is no poultry manure storage on the permitted site.

Maintenance checks are carried out after each crop cycle by F M Jones.

The complaints system is up to date, the last entry relates to a noise complaint. The matter was resolved after a new silencer was fitted to an exhaust.

Training logs are all up to date.

Control of access is in place across the unit to prevent unauthorised access to the site.

The site utilises potable water drawn from a borehole. The water quality is checked on a regular basis and the water passes through a UV filter and dosed with chlorine dioxide. AMS Agricultural Services based in Hereford are contracted to manage the dosing. Chlorine products are stored in a bunded area and waste chlorine drums are stored in sealed containers.

Waste is taken from the site by GD Environmental and EG Agriculture, waste transfer notes were available for inspection. Celtic Baits are contracted to remove carcasses, transfer notes were available for inspection.

Stocking number and animal movements are recorded. Avara provide feed for the stock,

which reduces protein and phosphorous in the diet over the crop life cycle. Dockets and samples of the feed are kept for each crop.

Poultry litter is exported from the site by Gamber Growers Ltd and Mercer and transferred to GP Biotec Ltd, Cwm Cayo Farm and Trostery Court. Export records are logged. Trostery Court has a manure management plan and soil analysis records. Analysis of the poultry litter was also provided.

The odour and noise management plans and the site plans are all up to date.

There were no issues identified with the drainage system.

Foot wear disinfectants are kept in suitable containers which do not overflow when used. The site has excellent bio security procedures.

Poultry litter is managed and any identified dampness issues are dealt with immediately. The water pressure in drinkers is checked to prevent leaks. These systems are checked and serviced after each crop rotation.

There were no issues identified during the inspection and there were no compliance breaches of the permit.
