Abril Industrial Waxes Annual Reporting CAR

The purpose of this compliance assessment report is to review the quarterly monitoring returns for Q3 and Q4 2025, the annual returns as required by permit condition 4.2.2

Quarterly reporting for emissions to Air and Sewer

The Q3 and Q4 reports were received on 30th October and 23rd January 2025 respectively, and showed no emissions breaches to air or water during these periods.

Annual returns – Water usage

A total of 248m³ of water was used by the site in 2025, an increase when compared to 2024 figures. Water used per unit output increased compared with previous years.

Permit EPR/BV5858IW condition 1.3.1 (a) requires the operator to take all appropriate measures to ensure that raw materials and water are used efficiently in the activities.
