4. Details of our assessment**4.1.2 Quarterly Reports and Annual Emissions Monitoring**

Cabot submitted forms A2, A3 and W1 for Q4 2024 on 29th January 2026.

The Q4 monitoring at A1 was delayed to January 2025 due to production downtime in Q4 2025. NRW were kept informed during delays.

Emissions to air of Chlorine, Chloromethanes, Hydrogen Chloride and Carbon Monoxide from emission point A1 are all compliant with the permit limits.

Emissions to water at emissions points W1, W2 and W3 are all compliant with the permit.

4.1.3 Annual production and performance parameters

Cabot submitted forms R1, WU1, E1 and PI1 for 2025 on 29th January 2026.

Cabot disposed of a total of 100.5 tonnes of waste in 2025 which is an increase compared to 2024.

Total waste for recovery in 2025 was 341.7 tonnes, which is a decrease compared to 2024.

Water usage in 2025 was 148,252 m³. This is a higher quantity than has been used in recent years. The water usage performance parameter has also increased to 23.63 in 2025 from 17.7m³/t in 2024.

Cabot have reported that a leak on mains potable water was found that would account for the increase in water usage.

Energy usage and CO₂ production both decreased compared to 2024.

Chlorosilane and Hydrogen usage

Chlorosilane usage has remained consistent with previous years.

Hydrogen usage appears to be steadily increasing since 2021.

4.1.5 Cabot environmental objectives EMS update

Cabot submitted an EMS update to NRW on the 30th January 2026 as per permit condition 4.1.5.

2.11 Cabot Site Closure and Decommissioning

- Notwithstanding condition 2.11.1 of Cabot's Permit, the Operator shall carry out a full

review of the Site Closure Plan at least every 4 years.

- In 2022 Cabot have reviewed the 2019 closure plan and concluded that the plan remains applicable. The closure plan should be reviewed again in 2026
