4. Details of our assessment

Assessment Details

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) assessment of Kennametal UK Limited's (hereafter the operator) Q1 to Q4 (January to December 2025) emissions monitoring data submission against the relevant environmental permit conditions for Reporting, Emissions & Monitoring and Notifications.

Reporting (IR4B)

Environmental permit condition 4.2.2 states:

Within 28 days of the end of the reporting period the operator shall, unless otherwise agreed in writing by the Agency, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

- (a) in respect of the parameters and emission points specified in schedule 5 table S5.1;*
- (b) for the reporting periods specified in schedule 5 table S5.1 and using the forms specified in schedule 5 table S5.4 ; and*
- (c) giving the information from such results and assessments as may be required by the forms specified in those tables.*

Compliance Assessment

- Monitoring data for emissions to air was submitted by the operator via email on 26 January 2026 (document reference: *Sust_Report_2025*).
- The emissions monitoring data was submitted within the 28 day reporting window which represents compliance with the requirements of the environmental permit.
- The emissions monitoring data submitted is for the reporting period specified in Schedule 5 Table S5.1 which represents compliance with the environmental permit.

4. The emissions monitoring data was not submitted using the form specified in Schedule 5 Table S5.4, however, all of the information required by *Air 1 06/08/07* was provided by the operator which represents compliance with the environmental permit.
