4. Details of our assessment

Mekatek Ltd Q4 2025 Monitoring Submission

This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q4 (October – December 2025) monitoring returns by Mekatek Ltd (the operator) for activities undertaken at Amex Park, Llanstephan Road, Johnstown, Carmarthen SA31 3NF under permit EPR-YP3937SH.

The following monitoring returns have been assessed within this Compliance Assessment Report (CAR):

- Quarter 4 (Q4): October – December 2025 point source emissions to water (W1).
- 2025 Annual Report

Quarter 4 (Q4): October – December 2025 point source emissions to water (W1)

The operator submitted the Q4 monitoring returns for the sampling and analysis of emissions to water at emission point W1 on the 27th January 2026.

Monitoring return data was submitted within the required Q4 reporting period, using the forms specified in schedule 4, TableS4.4, demonstrating compliance with permit condition 4.2.3.

Schedule 6 Notification

On the 14th January 2026 operator submitted a schedule 6 notification, containing a part A and B detailing exceedance of an emission limit at W1.

The composite sample retrieved during December, returned a Total organic carbon (TOC) analysis result of 69.8mg/l. Analysis result exceeds the TOC emission limit specified in Table S3.2. Breach of an emission limit value stated in schedule 3 is contrary to permit condition 3.1.2.

In accordance with non-compliance scoring guidelines, a non-compliance score of **C3** has been allocated against criteria **IR3A(1)- Emissions to water**.

Action: Investigate and identify the root cause of the December TOC emission limit exceedance, perform additional supplementary sampling of the effluent discharged to W1 following the exceedance.

All other parameters monitored during the Q4 reporting period were compliant with their associated emission limit stated in Schedule 3(b) Table S3.2.

Annual Report

Operator submitted 2025 annual report on the 11th February 2026 having been granted permission to submit the relevant reports post the deadline.

Operator has exceeded the annual permitted Mercury discharge limit stated in Schedule 3(b) Table S5.3 of the environmental permit.

- Permitted limit: 0.274 kg/year
- Reported annual value: 0.330 kg/year

The operator reports that the primary cause of the annual exceedance was an unexpected Mercury emission breach in July 2025. July breach was attributed to contamination of the composite sample. However, the specific cause of the contamination has not been identified by the operator.

Breach of an annual emission limit value as stated in schedule 3(b) Table S3.3 is contrary to permit condition 3.1.3.

In accordance with non-compliance scoring guidelines, a non-compliance score of **C3** has been allocated against criteria **IR3A(1)- Emissions to water**.

Action: Closely monitor Mercury concentrations and implement additional control measures if analytical results begin to show an upward trend.

Action: Produce a written procedure for the investigation and resampling of contaminated samples.

All other annually reported performance parameters and production values are deemed to be satisfactory.

This CAR report and assessment was undertaken on 17th February 2026. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS system has been altered to 31st Dec 2025.
