4. Details of our assessment

This was an unannounced, site visit made by Alex Underhill of Natural Resources Wales (NRW). The purpose of the inspection was to assess compliance against the tier 3 bespoke Environmental Permit (EPR-ZP3698FP).

The weather was fine but recent heavy rain had been noted.

Previous inspection:

No permit breaches were observed during the last inspection dated 09/06/2023. Please see Compliance Assessment Report CAR_NRW0042369 for further detail.

Permit Breaches:

No permit breaches were recorded during this inspection.

General Management (W1A):

The site is required to be operated in accordance with a written management system that identifies and minimises risks of pollution.

General observations:

The site was generally clean and well organised with good segregation of waste types and good waste storage practices were observed. Having had a full walkaround of the site, the site was well maintained, EMS is very comprehensive, TCM was on site, her time is split between 4 CA sites. Batteries stored in covered bins inside a container. Li-On batteries are accepted and stored in a separate bin to other batteries.

Fridges are stored under purpose build shelter to protect from the weather. Gas canisters stored correctly in locked cage.

The Site (W2D):

Despite recent heavily rainfall, the site did not suffer from pooling water and was clear and tidy. All specified waste sections were kept separate. TCM confirmed weekly gulley sucker on site to kept drains clear. Brambles and bushes around the perimeter fence had been cut back to maintain the fences integrity, which TCM confirmed was routinely done.

Record (W4A):

Up to date EMS and Site Permit were readily accessible on site. Latest Waste Return Notes up to date, up to Q4 2025.

Technical competence:

Penny Weaver is the current TCM for the site and holds the appropriate WAMITAB certification. Continuing Competence certificate was shown with expiry date of 16/04/2026.
