Reporting (IR4B)

Condition 4.2.2 of the environmental permit states:

A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year. The report(s) shall include as a minimum:

(a) a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data.

Note – as previously outlined in CAR_NRW0046492, issued on 28 February 2025, environmental permit EPR/XP3833UB fails to reference tables S4.2 and S4.3 of Schedule 4 in condition 4.2.2. Typically, condition 4.2.2 of a modern environmental permit includes a part (b) which states:

(b) the performance parameters set out in schedule 4 table S4.2 using the forms specified in table S4.3 of that schedule.

Nevertheless, the operator correctly provided NRW with results for the performance parameters set out in table S4.2 of Schedule 4 using the reporting forms specified in table S4.3 of Schedule 4.
