**4. Details of our assessment**

This compliance assessment report follows the submission of the 2025 monitoring returns.

As detailed in CAR NRW0042311 the HDU and associated infrastructure ceased operation in June 2023 and was removed during Q3 2023. Agreement was made relating to the associated monitoring requirements at that time.

- Efficacy monitoring is no longer required.
- Air emissions monitoring is no longer required.

**2. Performance of activities**

Condition 4.2.2 (b) & (c) of the permit requires a report on the performance of the permitted activities over the previous year to be submitted. Nil returns provided.

**3. Emissions to sewer**

Condition 4.2.3 (b) & (c) of the permit requires a report on monitoring data, which were submitted to NRW in accordance with the permit:

- Emissions to air - no longer required.
- Emissions to sewer – flow readings submitted in accordance with the permit.

**4. Quarterly Waste Returns**

Condition 4.2.5 requires that quarterly waste returns for the previous quarter shall be submitted within one month of the end of the reporting period.
