4. Details of our assessment

DCWW self reported a spill to the environment from Bagillt West SPS on 27th January 2026. This was caused by rag build up around pumps, which led to a discharge to the environment before PFF was achieved.

DCWW submitted a storyboard, detailing their investigation findings and actions they will take to reduce the likelihood of reoccurrence.

On the morning of the 27th Jan 2026 an Operator attended site and found the well to be at high level, with the pumps underperforming. A Mechanical Technician was called to investigate the issue and both pumps were lifted. Rag build up was found to be surrounding the pumps and non-return valve which had caused it to stay open. The rag restriction was cleared and equipment returned to working order. A full well clean has been scheduled and DCWW have increased cleaning frequency going forward.

Telemetry data shows well level during the time of the spill. Spill duration was approximately 07:45 – 10:10.

Discharge from site was during heavy rainfall and via a 6mm rotating brush screen which would've removed larger solids and rags from the

Ensure discharges occur only when PFF is achieved.
