At this time, we do not intend to take any further action.

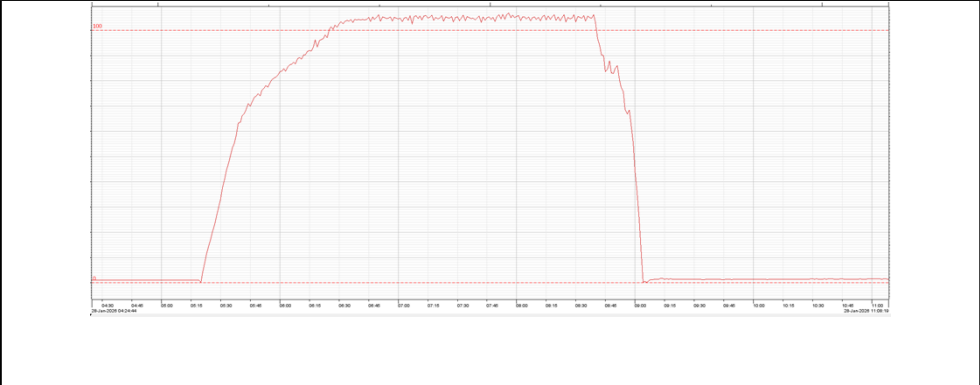
This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On 28th January 2026, Bagillt East SPS was found to be high level with low flows. Operators on site dropped the level to stop further spills. The problem was found to be airlock in the pumps caused by the low level "off" setting being too low and therefore allowing air to enter the pumps. The "off" level was raised from 0.6 to 1m. The storyboard report provided by DCWW to NRW states that the pumps have been running as designed since the change. Samples were taken from the SPS as the outfall was not safely accessible.
