4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised to review the 2025 annual monitoring data for the Bryn Posteg Gas Utilisation Plant (GUP).

The GUP is operated under a separate environmental permit to the main landfill site which, authorises the activities of the on site gas engine only. The flare although situated within the compound, is an authorised part of the landfill permit. An annual report was submitted containing the data required by the landfill permit and the GUP. The data relating to the landfill is discussed in CAR_NRW0050703.

One gas engine is currently operational and therefore only one set of emissions testing was undertaken in this reporting period.

Monitoring of the landfill gas engine at Bryn Posteg took place on 18th December 2025. This emissions monitoring was completed by a third party, MCERTS accredited test house. The result was 1193mg/3 for Volatile Organic Compounds (VOC's) against an Emission Limit Value (ELV) of 1000mg/m³. This result is within the limits of uncertainty as specified in LFTGN08.

It should be noted though that the VOC reading would be considered a breach if the level of uncertainty of +/- 45.1mg/m³ as stated in the report by Element was used.
