4. Details of our assessment**Introduction**

This Compliance Assessment Report has been completed in response to the submission of the quarterly and annual 2025 monitoring returns by the operator, Valero Energy Ltd.

Quarterly Returns

The returns specified by permit condition 2.4.3 Reporting were submitted to NRW within the reporting period:

- The Q1 2025 (January to March) submission included all the results for quarterly parameters required over this period.
- The Q2 2025 (April to June) submission included all the results for quarterly parameters required over this period.
- The Q3 2025 (July to September) submission included all the results for quarterly parameters required over this period.
- The Q4 2025 (October to December) submission included all the results for quarterly parameters required over this period.

The reported emissions were within limits specified in the permits for all of the above monitoring periods.

2025 Annual Returns

The 2025 annual and half-yearly returns submission comprised the reporting forms for emissions to air and water, and energy and performance reporting forms.

The reported emissions were within emission limits specified in the permit for the above monitoring periods.

A letter report covering the requirement by Improvement Condition 35 to annually report on management of flaring was also included.

The Large Combustion Plant returns were also submitted in full for the following LCP units:

- LCP371
- LCP372
- LCP373
- LCP374
- LCP375
- LCP652

We note that LCP652 (Cogen) was only operated during the end of Q4 following refurbishment and the returns report much lower operating hours than the other LCP, reflecting this downtime.
