This Compliance Assessment Report (CAR) has been issued in response to the submission of the 2025 annual monitoring returns by **RWE Generation UK plc** (the operator) for activities at Pembroke Power Station, West Pennar, Pembroke, Pembrokeshire, SA71 5SS under permit **EPR-DP3333TA**.

This CAR was undertaken on **17 February 2026**. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS has been altered to **31 December 2025**.

**Compliance Assessment**

In accordance with Condition 4.2.3, the operator is required to submit all annual reports within 28 days of the end of the reporting period. The operator submitted the annual monitoring returns on **13 January 2026**, which is within the permitted timescale and therefore compliant.

Emissions to Air have been accurately reported for LCP1 LCP2, LCP3, LCP4, and LCP5. The submitted emissions data for Nitrous Oxide (NO<sub>x</sub>) and Carbon Monoxide (CO) are within the parameters specified in the permit and are compliant.

Quarterly monitoring returns for Emissions to Air and Emissions to Water were submitted for Q1, Q2, Q3 and Q4 within the required reporting period. All monitoring results were within the emission limit values set out in the permit, with no breaches identified for any emission points.

All submissions were provided using the correct reporting formats as specified within the permit

**No issues or non-compliances were identified** in relation to the information submitted by the operator.

### **Performance Reports**

The operator completed and submitted the interpretative review in accordance with condition 4.2.2 of the permit. RWE's annual Performance Report (*EPR - DP3333TA Annual Performance Report 2025*) was submitted to NRW on 13 January 2025 and contained all information required.
