### 3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

### 4. Details of our assessment

This Compliance Assessment Report (CAR) has been prepared following a review of the annual air monitoring and annual reporting requirements.

#### **1. Annual Monitoring**

The operator submitted the annual monitoring report for emission points A1, A2 and A3, in accordance with Permit Condition 4.2.3.

All parameters reported were compliant with the Emission Limit Values (ELVs) specified in Permit Condition 3.3.1, Schedule 3(b), Table S3.1.

#### **2. Annual Reports**

The annual report was submitted in line with Permit Condition 4.2.2, Schedule 4, Tables S4.2 and S4.3.

A permit variation has still not been submitted to include the additional CHP unit and its associated emission point. As a result, this emission source was not included in the latest round of air emissions monitoring.

#### **3. Additional CHP unit and Subsequent Extra Emission Point**

The operation of the additional CHP unit without the required permit variation application constitutes a breach of permit condition 2.1.1. This has been recorded as a Category 3 breach against (IR2A) Permitted activities.

The installation and operation of a non-permitted point source emission point also constitutes a breach of Permit Condition 3.1.1. This has been scored as a Category 3 breach against (IR3A(2))

Emissions to air.

An action in CAR NRW0049634 previously required the submission of a permit variation by 30/01/2026. As this action has not been completed, it constitutes a breach of Permit Condition 1.1. This has also been scored as a Category 3 breach against (IR1A) General Management.

#### **4. Actions**

While it is acknowledged that a pre-application request has been submitted to Natural Resources Wales (NRW) on the 10/02/2026, a permit variation for the additional CHP unit has not yet been received. As the CHP unit is a directly associated activity, it must be included within the permit.

Action 1: Submit a permit variation application to NRW for the operation of the additional CHP unit by 31/03/26.

## Important information

### Legal status of this report
