Quarter four (October – December) 2026 Waste Returns

Returns submitted within the reporting window. All EWC codes were compliant with the permit, including no acceptance of the voluntary prohibited EWC codes listed in CAR_NRW0039332. The returns are accepted.

Emissions to Sewer – Discharge Point S1

The returns were submitted within the reporting window. All parameters were within discharge consent limits with the exception of copper, the noncompliance scoring for which is captured in CAR_NRW0050302. Report accepted.

Annual reporting returns 2026

Energy:

Total energy consumption (calculated as primary energy) for 2025 was reported as 1082.374 MWh. MWh, which consistent with previous years.

Total specific usage (KWh per tonne of waste accepted) in 2025 shows an increase on the 2024 figure, with a value of 68.1 KWh/T compared to 65.7 KWh/T reported in 2024, but still below the 2023 specific usage..

Castle to purchase a HVO / diesel mixture for on site use and have seen a reduction in 1000 litres in 2025 compared to 2024.

Water consumption

Water consumption was reported at 16,177 m³ which represents a slight decrease on 2024 usage.

Prior to 2023, an estimation process had been utilised to provide a water usage estimate, measured data now appears to show a similar usage trend.

Raw materials:

Castle continue to not utilise any raw materials within he process.

Improvements:

Continued improvements to infrastructure has been made across the site, the operator has reported continued investment in improvement to tank maintenance activities with further cleaning and painting.

The operator has reported the introduction of the 5S across the facility, which has improved housekeeping and general organisation.
