PB Gelatins UK Limited

EPR/DP3030ZC

This compliance assessment report (CAR) details the review of the annual performance report as required by permit condition 4.2.2 for the 2025 period.

In November 2024, it was announced that PB Gelatins were considering ceasing the production of gelatin at the Treforest site as part of a global restructuring, In July 2025 the gelatin production ceased, and the blending activities ceased in October 2025. As such a review of the energy usage and raw materials usage will not be undertaken, as it is not possible to perform trend analysis, there will be no benefit to identifying any areas of improvement and all operations have now ceased at the facility.

PB Gelatin UK Ltd are noted to have met the permit reporting requirements of permit condition 4.2.2 and the report is accepted.

A final site inspection will be organised to assess the site de-commissioning and it is expected that PB Gelatin will apply to surrender the permit once decommissioning has been completed and the subsequent site condition monitoring is undertaken.
