We need more information about your application

Thank you for your application received on 13/11/2025. I need to ask you for some more information before I can do any more work on it. Please would you:

- Provide the document referenced in form Part a Section 6a as “Partnership Details – 3rd Member”;
- Provide a summary of your Environmental Management System. Please ensure that your summary includes sufficient detail. For further guidance please see: [How to comply with your environmental permit](#);
- Provide an updated site plan. The site plan should clearly show the installation boundary in green and should only display aspects of the site found within the green line boundary. It is currently unclear where the sites boundary is positioned and therefore which aspects of the site plan submitted are found within the site boundary; and,
- Provide further clarification on the drainage arrangements for surface water runoff at the site. In the existing permit, surface water is discharged to a surface water soakaway to the southwest of the sheds. However, in the new plan provided, it seems that surface water runoff now discharges to an attenuation pond to the northwest of the site.

Please reply within 10 working days from the date of this letter. If we don't hear from you we must return your application and fee. We will keep 14% of the charge to cover the cost of the assessment work done.
