Site Report

The abstraction is currently not in use. There are ongoing meetings and correspondences surrounding the restoration of the site with the local authority and the Licence Holder, which involve re-commencing dewatering of the pit void lake to aid restorations works.

The Licence Holder has submitted a proposed dewatering plan for the restoration works, with the proposed abstraction re-commencing in the summer. However this is subject to finalisation of the restoration plans with the planning authority.
