4. Details of our assessment

On the 10th of February 2026, NRW were notified of a sample failure for Chirk Fishery. The failure was in relation to the suspended solids value at the outlet exceeding the suspended solids value at the intake by 5mg/l, as per the permit. This sample was taken on the 13th of January 2026.

The samples taken at the inlet and the outlet had a suspended solids value difference of 7.5mg/l against the permitted 5mg/l.
