Introduction

This Compliance Assessment Report (CAR) is an assessment of the Annual Report 2025 which has been submitted by Celtic Chemicals Ltd (the Operator).

Scope

The following monitoring reports have been assessed within this Compliance Assessment Report (CAR):

- Env agency Form L1 2025

2025 Annual Submission Assessment

The annual report (*Env agency Form L1 2025*) was submitted by the Operator on the 19th of January 2026, which was within the timeframe (by the 31st of January 2025) specified by the EPR permit. Furthermore, the report details all informative requirements set out by NRW in accordance with permit condition 4.2.1.

Key Observations

Site Boundary

There is an element of processing which continues to be undertaken outside the permitted boundary of the permit, it is the understanding of NRW that this has been the case since Quarter 1 2024.

Permit condition 2.2.1 below stipulates:

'The activities shall not extend beyond the site, being the land shown edged in green on the site plan at schedule 2 to this permit.'

Celtic Chemicals Ltd submitted a permit variation application on the 26th of August 2025, this however was returned by NRW on the 18th of September 2025 as it was the incorrect type of application and lacked sufficient detail. It is the current understanding of NRW that there has been no follow-up permit variation application submitted by the Operator since this application return in September 2025 .

Celtic Chemicals Ltd must seek to vary their permit to incorporate these new industrial units (Units 17 – 20), without delay.

Action:

Celtic Chemicals Ltd must submit a revised permit variation application that incorporates the additional industrial units into the site boundary, as well as any other aspects of the Site that may not yet have been identified by NRW. This must be submitted within the specified timeframe.

Please note: This CAR report and assessment was undertaken on 20th of February 2026. However to ensure that the non-compliance score is attributed to the correct financial year (for billing) the date on CARS system has been altered to 31st of December 2025.
