### 4. Details of our assessment

An incident was reported to Natural Resources Wales on the 14th January 2026 stating:

*Sewage appears to be discharging into the river, collecting all along the outflow head wall. There is also the presence of sewage fungus.*

As there is a sewage treatment works in close proximity to the location of the report, a Polfax was raised with DCWW. This included pictures of the outfall showing signs of fungus build-up.



Due to the time of the report coming in, and the Polfax being sent, a conversation was had with the out of hours DCWW investigating officer. Due to the historic nature of the report, a decision was made to follow this up in hours with the pollution technician.

A call was made to the DCWW pollution tech on the morning of the 15th January 2026. This found that a job had been raised the previous night and a crew attended the works and found it to be operating as designed. The outfall wasn't checked at this point due to being in the hours of darkness.

The follow up inspection in daylight carried out by the pollution technicians (AGA + BGA) also found the works to be operating as designed, but a check of the outfall wasn't carried out.

A background check on the works carried out by the pollution technician found concerns have been raised in the past over the fields around the outfall flooding, causing flows to be held back. To avoid the flows being held back around the outfall, it was mentioned that a large stretch of the watercourse would need to be dredged.

As this watercourse is classed as main river, a Flood Risk Activity Permit would be required from NRW to carry out any works within this section.

The licence contains flow rate limits and numerical limits. Please can the flow rate data for the month before the incident report, along with any sampling results around this period be provided to NRW by the 27th March 2026. If no samples have been taken around this time, I would ask that this is carried out to ensure the discharge is compliant with the limits set within the licence.
