4. Details of our assessment

Natural Resources Wales (NRW) Waste Regulation Officers Mark O’GORMAN and Carla CURTIS attended KJ Services Holdings Limited, Capital Valley Industrial Park, Rhymney, Tredegar, NP22 5PT at 11:15am on Tuesday 10th February 2026 to conduct a planned site visit and inspection of Permit site EPR-DB3298FN. The weather conditions were cloudy and wet at the time of inspection. NRW officers O’GORMAN and CURTIS met with Environment manager Kelly SHERRATT and Director William THOMAS who showed NRW officers around the permitted area and explained operations and site procedures.

Permit Inspection

Kelly SHERRATT discussed with NRW officers the ongoing plans at the site. The discussion covered improvements being made to the site including improved drainage and resurfacing of ground areas, installation of a new wash plant and the recently issued mobile plant permit.

NRW officers did not witness any offensive odours, dust or excessive noises during the site inspection. Security of the site appeared satisfactory.

The site has also made appropriate use of an S2 waste exemption to responsibly manage historic material on site. As the historical material falls outside of permit conditions the operator must adhere strictly to the conditions of the S2 waste exemption by ensuring that the material is coded correctly, storage limits are adhered to in addition to maximum storage times, and that the S2 exemption is used to only securely store material.

Image 1 shows the relevant waste codes for the current material on site, tonnage at any one time and period allowance for material to be stored. The S2 exemption only allows for the secure storage of waste. The operator must adhere to these conditions to comply with the S2 exemption.
