The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) assessment of the annual reports and Q4 waste returns for Martin Road Hazardous Waste Transfer (Shield).

Quarter four 2025 Waste Returns

The Waste returns for quarter four (October – December) 2025 were received on the 20th of January 2026. A total of 13.46 tonnes was received and 12.3 tonnes removed during this quarter. All wastes are compliant, and the report is accepted.

Annual Returns

Annual reporting forms Performance 1, Energy 1 and Water Usage 1 were submitted to NRW on 23rd February 2026. Late submission of annual reporting forms has been assigned a **category 4 minor non-compliance due to a breach of permit condition 4.2.2**

Action: Provide a root cause for the late reporting as per permit condition 4.2.2 and a plan of action to ensure that annual reports are submitted as per the permit. **Due 31 March 2026**

Legal status of this report
