Site was inspected on the 12th February 2026, weather was dry.

This permit for a Klargest treatment plant which services office and welfare facilities including pithead showers for employees. The maximum approximate population equivalent for the treatment system is 270 (however the site operates on a rotation shift system)

Representatives of Energybuild Limited confirmed that there is an inspection schedule in place which dedicated surface staff undertake as part of the site management system. It was also confirmed that there is a service and maintenance contract in place with the treatment plant manufacturers.
