4. Details of our assessment

Site was inspected on the 12th February 2026, weather was dry.

The settlement lagoons appeared to be in good condition and that the treatment system hasn't received contaminated water (solids) from the surface operation for several years and is consequently providing drainage for coniferous woodland and acid grassland.

We are therefore of the opinion that these are background and natural pH levels. We will continue to monitor the situation and at this stage we do not recommend that the operator undertakes pH buffering, as this will inevitably involve the addition of chemicals - given the remote location and known wild camping/swimming activities such an intervention may present a greater water pollution and public safety risk.
