Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

At 10:00 am on the 10th February 2026 as site inspection was undertaken by NRW officers Phil Harper, Lead Specialist Industry & Waste Regulation, Ricky Hartleb and Hannah Ibbotson, Senior Industry & Waste Regulation. This was an announced familiarisation visit for officers to get an overview of the process and the sites permit. The site was operational at the time of the inspection.

New Formox Plant

The new formox plant was not operational at the time of the inspection. A variation to permit the use of the new formox plant is currently in NRW's determination queue.

Boiler Replacement

During the visit the replacement of the natural fired boilers at emission point A17 was discussed. NRW understands that the operator is looking to replace the natural gas fired boilers with new units which are concurrent with best available techniques.

Action 1: Inform NRW of timelines for this work to be completed by the 3rd April 2026.

IBC Storage

During the inspection it was noted that a bund used to store IBCs containing liquid waste near the formox plant was full of IBCs. The IBCs were stacked up against edge of the containment at two IBCs high, such that if a jetting event occurred liquid would spill out of secondary containment and onto the sites hard standing.

Whilst the site benefits from a bund wall, hardstanding and sealed drainage to lagoons, these measures are regarded as the sites tertiary containment.

Permit condition 3.2.3 *“All liquids in containers, whose emission to water or land could cause pollution, shall be provided with secondary containment, unless the operator has used other appropriate measures to prevent or where that is not practicable, to minimise, leakage and spillage*

from the primary container.”

A **category 3 score** has been applied under subheading IR3B Emissions of substances not controlled by emission limits.

The observations indicates that the storage of wate containing IBCs is not being managed in line with a robust environmental management procedure.

This a permit breach against permit condition 1.1.1a.

A **category 3 score** has been applied under subheading IR1A.

NRW advises that the operator reviews publicly available documentation which provide guidance about what is regarded as secondary and tertiary containment and ensures that management procedures are robust enough to provide the required level of management.

Action 2: Review the relevant sections of the sites management system and implement any improvements by the 3rd April 2026.
