### 4. Details of our assessment

#### 2025/2024 annual reporting compliance assessment

##### 2024 monitoring reporting

Reporting for 2024 has been submitted 12 months late due to personnel changes. Continuity arrangements for environmental permit compliance should be embedded in the management system so that interim/deputy roles and responsibilities are automatically allocated when a primary role is vacant.

**ACTION: Navigator Terminals to confirm details of EMS arrangements in place to ensure continuity of environmental permit compliance when a primary responsible role is vacant by 30 April 2026**

NRW notes that around 10 tonnes of non-compliant firefighting foam was disposed of during 2024. It is not clear from the waste data whether fire system flushing took place to ensure no residual contamination remained in the system which might contaminate the fresh foam and render it non-compliant if above the specified PFAS limits.

**ACTION: Navigator Terminals to confirm details of fire system flushing and testing to verify compliance with PFAS residual levels by 30 April 2026**

##### 2025 monitoring reporting

Leak detection and repair programme is undertaken every 6 months. Methanol tank rim seals were replaced in 2024 and estimated fugitive methanol emissions are minimal. Details of fugitive emissions estimation standard or code are unclear from the reporting.

**ACTION: Navigator Terminals to confirm details of fugitive emissions estimation methodology, including any standard or code followed by 30 April 2026**

All reporting was in compliance with the permit requirements.
