Waste Acceptance Review

A desk top audit of the operator submitted waste returns was undertaken on 25th February 2026 by the sites regulating officer. The returns which have been reviewed are Q1 2025, Q2 2025, Q3 2025 and Q4 2025.

Q3 2025: 15,192.018T

Q4 2025: 24,024.878T

Total: 73,223.504Tonnes

Waste quantities accepted at the site were found to be compliant and below maximum limits permitted by the environmental permit.

The EWC codes and description of wastes accepted at the site were also compliant with those authorised under the operator's environmental permit.

The total quantity of waste accepted in 2025 is broadly consistent with volumes received in 2022 and 2023.

The operator recorded accepting a higher waste volume in 2024, primarily due to an increase in leachate waste (EWC 19 07 03) treated. This increase correlates with the exceptionally high rainfall experienced during 2024.

WAMITAB Competency & Attendance

NRW requested the operator provide a copy of the original qualification, and all certificates of continuing competency for the Technically Competent Manager on site.

Operator provided certificate evidence of continued competency on the 24<sup>th</sup> November 2025. Appropriate personnel certificates issued 2024.

Attendance of the sites two technically competent personnel, 104.69% against the site's operational hours.
