4. Details of our assessment

DCWW self reported a spill to the environment from the Dee Cottages SPS on 1st February 2026. The spill was caused by an airlocked pump, resulting in a discharge to the environment before PFF was achieved.

DCWW submitted a storyboard, detailing their investigation findings and actions they will take to reduce the likelihood of the issue reoccurring.

DCWW reported that the SPS reached high level overnight, telemetry data shows that the spill duration was approximately 23:55pm (31st January) to 11:11am (1st February). Crews attended site on the morning of 1st February and found Pump 1 had airlocked; mechanical staff were called to resolve the issue and tankers were used to manage flows during the repair. Once the airlock was cleared, the station returned to normal levels and has operated as designed since.

Due to the weather at the time of the spill and the location of the discharge, no samples were collected. However, significant rainfall prior to the incident means any discharge was likely to have been heavily diluted and ongoing monitoring has reported no further issues.

Actions:

Notify NRW if any further issues occur.

Ensure discharges occur only when PFF is achieved.
